Report

Welcome to the first Report & Accounts of XirCammini for the year of activity 2019.

XirCammini is a membership-based, not-for-profits, non-denominational and non-sectarian association open to all who support its aims, primarily focused on generating interest in pilgrimages or hiking of ancient routes or pilgrimages in Europe and beyond. We are registered with the Office of the Commissioner for Voluntary Organisations.

To achieve its objectives, XirCammini is open not only to those who have already undertaken a Camino, but welcomes as members all who are interested in its aims and activities.

XirCammini submitted its application on All Saints' Day (1st November 2018) and was issued with a certificate of registration (VO1646) in February 2019. XirCammini is also a registered trade mark 59214 belonging to the association and protected by law. More information about XirCammini is available on our website: www.xirCammini.org

The 1st year of operations was dedicated to building the necessary governance structure, attracting members, rolling out the website and also starting trekking activities. The following is a summary of this year's activities:

The median age of members is between 35 years – 64 years old and the gender distribution is 64% ladies and 36% men.

Members are very active within our social media forum. Interaction with members on social media averages at close to 2,000 posts and comments per month with over 350 members active each month.

The Committee has also dedicated significant time and effort to developing an ancient walk in Malta (https://xircammini.org/route/malta-universal-peace-walk-1543ad/) which it intends to roll out in 2020. More information on this will follow shortly.

Notes to the Report & Accounts:
