

## Report & accounts for the year of activity: 2020

#### Introduction

This Annual Report is for XirCammini's 2<sup>nd</sup> year of operations and covers the period 1<sup>st</sup> January 2020 to 31<sup>st</sup> December 2020.

XirCammini is a membership-based, not-for-profits, non-denominational and non-sectarian association open to all who support its aims, primarily focused on generating interest in pilgrimages or hiking of ancient routes or pilgrimages in Europe and beyond. We are registered with the Office of the Commissioner for Voluntary Organisations. To achieve its objectives, XirCammini is open not only to those who have already undertaken a Camino, but welcomes as members all who are interested in its aims and activities. Despite having planned a full programme of local and overseas walks for 2020, XirCammini had to cancel all of its overseas activities and social, fund-raising activities. Therefore, its activities were restricted to local walks (<a href="https://xircammini.org/universal-peace-walk/">https://xircammini.org/universal-peace-walk/</a>) While it was intended to roll out the first Universal Peace Walk in March 2020, this event was also cancelled due to Covid-19.

The median age of members is between 35 years – 64 years old (65% fall within this band) and the gender distribution is 65% ladies and 35% men.

Members are very active within our social media forum with 375 posts, around 750 comments and almost 7,500 reactions by almost 500 active members.

#### **Financial Report**

Unfortunately due to Covid-19 we (a.) cancelled all our fund-generating activities and (b.) deferred the decision to introduce a membership fee until 2021. Our local walks are all free-of-charge.

There were no donations this year and we returned any 2020 deposits collected in 2019 on cancelled feegenerating activities. So, after refund and some miscellaneous expenses our cash position deteriorated from  $\epsilon$  1,000 cash in bank at the end of Dec 2019 to  $\epsilon$  420 at the end of Dec 2020.

#### Conclusion

Prior to Covid-19 we were able to sustain XirCammini from revenue-generating activities for members, donations by an administrator and voluntary services of some members, without the need to introduce a membership fee.

As a result of Covid-19, with the cancellation of activities, XirCammini's already modest revenue stream was depleted.

Emphasis in 2021 will be in establishing a partnership with the Ministry of Tourism vis-à-vis the Universal Peace Walk with a view to making it more widely known an accessible even for tourist hikers, re-introducing walks later in the year, strengthening local and overseas affiliations and also activating the annual membership fee.

I would like to conclude by thanking all volunteers (administrators, trek leaders, Wed-Group Leaders etc.) and all members who participated in our events and urge everyone to continue building on this in 2021 and beyond.
