

### Introduction

This Annual Report is for XirCammini's 5th year of operations and covers the period 1st January 2022 to 31st December 2023.

XirCammini is a membership-based, not-for-profits, non-denominational and nonsectarian association open to all who support its aims, primarily focused on generating interest in pilgrimages or hiking of ancient routes or pilgrimages in Europe and beyond. We are registered with the Office of the Commissioner for Voluntary Organisations. To achieve its objectives, XirCammini is open not only to those who have already undertaken a Camino, but welcomes as members all who are interested in its aims and activities. - 2023 was our second full year of activities following a slow start in 2021 subsequent to the Covid-19 pandemic.
- Membership continues to grow from strength to strength and
- our itinerary of local and overseas trekking activities was very well subscribed.
- Substantial work was also achieve on the <u>XirCammini</u> website as well as on the <u>Camino Maltes</u>, <u>Mariae Melitensis</u> and <u>Sancti Pauli</u> websites.
- A year after the Universal Peace Walk 1543AD and the Camino Maltés recommenced in earnest, pilgrims have exceeded 500 from more than 15 nationalities.

We want to take this opportunity to thank all XirCammini members for their annual contributions, all XirCammini volunteers with whose commitment we have achieved so much, government entities particularly the Maltese Embassy to Spain, the Spanish Embassy to Malta, Heritage Malta and Malta Tourism Authority, the Regional Associations of Local Councils and the Mayors and Councillors and cultural managers of Local Councils in Malta who shared in our vision and enthusiasm, Camino associations in Sicily and Sardinia and the Federación Española de Asociaciones de Amigos del Camino de Santiago.

### Meetings

The Board held quarterly meetings online / informally.

### **2023** Activities

In 2023 XirCammini held close to 70 walks divided into Wednesday and Weekend Walks (local) and overseas trekking / Caminos in Spain, Ireland and Italy.

We also held the Universal Peace Walk 1543AD and launched the Camino Maltés, with group walks in March and November. We reached an agreement with the Malta Tourism Authority (MTA) to sign-post the Universal Peace Walk, the Camino Maltés, the Camino Mariae Melitensis 1432AD and Perreginatio Sanci Pauli 60AD with the assistance of MTA. We also participated with them in the Fairway Camino Fair in Santiago de Compostela, Spain in November 2023.



Members are very active within our social media forum on both the XirCammini Page and the XirCammini Community on Facebook. To a lesser extent there is also visibility and some activity on LinkedIn.

## **Financial Report**

2023 has seen an increase in membership subscriptions (our main source of income) and sponsored trekking activities which also contribute financially to our VO. There were no donations in 2023 but we received a MTA grant to recoup costs incurred in the Universal Peace Walk 1543AD and/or the Camino Maltés projects.

The registered membership subscriptions, sponsored trekking activities and the MTA grant have contributed positively to the VO resulting in a net surplus to XirCammini of  $\in$  4,999 ( $\in$  6,005 in 2022). With the increased activity, particularly the roll out of the local Camino projects, the two founding members increased their long-term, zero interest loan from  $\in$  5,000 in 2022 to  $\in$  5,562.73 in 2023.

### Conclusion

The emphasis in 2024 is in consolidating our efforts on <u>Camino Maltés</u>, the <u>Universal Peace Walk 1543AD</u>, Camino <u>Mariae Melitensis 1432AD</u> and <u>Perregrinatio</u> <u>Sancti Pauli 60AD</u> and in rolling out Itinerario de Mello and Melita Mariana walks.. For this we continue working closely with the Faith Tourism Directorate of the <u>Malta Tourism Authority</u>, with <u>Heritage Malta</u>, the <u>Maltese Ambassador to Spain</u> and, internationally, with <u>Aleteia</u> through the Malta Tourism Authority, the <u>Federación Española de Asociaciones de Amigos del Camino de Santiago</u> to further develop locally and regionally heritage-faith tourism walks.

We also continue to further cement our relationships with like-minded NGOs within the region, particularly Sicily, Sardinia and Spain as well as growing our visibility and membership within the local, regional and international hiking community.
